This Free POS System Placement Agreement ("Placement Agreement") is entered into by and between Hubwallet Inc. ("Hubwallet") and the undersigned merchant ("Merchant") in connection with Merchant's participation in Hubwallet's Free POS program.

1. Incorporation; Priority. This Placement Agreement is incorporated into and forms part of the Hubwallet Software and Service Agreement (the "Service Agreement") accessible at www.hubwallet.com/terms_and_conditions/us and the applicable Merchant Processing Agreement ("MPA"). All capitalized terms not defined herein have the meanings set forth in the Service Agreement. In the event of any conflict or inconsistency between this Placement Agreement and the Service Agreement or MPA, the Service Agreement shall control.
2. POS System Placement; Ownership. Hubwallet agrees to place, at no upfront cost, certain point-of-sale equipment and related peripherals (the "Equipment," as defined in the Service Agreement) at Merchant's business location for use solely in connection with Merchant's payment processing relationship with Hubwallet. All Equipment is and shall remain the sole property of Hubwallet. This Placement Agreement is a license and bailment only and does not constitute a sale, lease, or transfer of ownership.
3. Return of Equipment. Upon termination, suspension, expiration, loss of eligibility under the Free POS program, or upon Hubwallet's written demand, Merchant shall immediately cease all use of the Equipment and return all Equipment strictly in accordance with the Service Agreement, which shall govern exclusively with respect to return timing, condition, shipping responsibility, and non-return consequences.
4. ACH Authorization. All amounts owed in connection with the Equipment or this Placement Agreement shall be collected pursuant to the ACH authorization set forth in the Service Agreement.
5. Personal Guaranty (Limited to Equipment Obligations). In consideration of Hubwallet's placement of Equipment at no upfront cost, the undersigned individual ("Guarantor") hereby unconditionally and irrevocably guarantees to Hubwallet the full and prompt performance of Merchant's obligations solely relating to the Equipment under this Placement Agreement and the Service Agreement, including without limitation (i) return of the Equipment, (ii) payment of any equipment recovery, non-return, damage, or replacement charges, and (iii) any costs of enforcement relating thereto. This guaranty is a guaranty of payment and performance and not of collection, is continuing, joint and several (if more than one Guarantor), and shall survive termination or expiration of the Placement Agreement and the Service Agreement. Guarantor waives notice of acceptance, presentment, demand, protest, and any requirement that Hubwallet first pursue Merchant or exhaust any other remedy. ACH Authorization. All amounts owed in connection with the Equipment or this Placement Agreement shall be collected pursuant to the ACH authorization set forth in the Service Agreement.
